

## **SUBWAY® GOLDEN TOKEN INSTANT WIN GAME**

### **OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AT THE TIME OF PARTICIPATION.**

**VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

The Subway® Golden Token Instant Win Game (“Game”) is sponsored by Subway Franchisee Advertising Fund Trust Ltd. (“SFAFT”), 325 Sub Way, Milford, CT 06461 (“Sponsor”) and is administered by Prize Logic, LLC, 25200 Telegraph Road, Suite 405, Southfield, MI 48033 (“Administrator”).

- 1. GAME PERIOD:** The Game begins at 12:00 PM Eastern Time (“ET”) on October 15, 2018 and ends at 11:59:59 PM ET on November 15, 2018 (“Game Period”). The Administrator’s computer is the Game official clock.
- 2. ELIGIBILITY:** The Game is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age at the time of participation. Employees of Sponsor, Administrator, Gatorade, PepsiCo Foodservice, Scrum 50, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Game Entities”), and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in Puerto Rico, all other United States Territories and Possessions and overseas military installations, and where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Game. For purposes of the Game, an entrant’s residential address and email address will be the physical address and email address submitted at the time of registration. Entrants will not be allowed to change their physical or email addresses.

- 3. HOW TO PARTICIPATE:** There are two (2) ways to participate:
  - A. Qualifying Purchase:** To participate via qualifying loyalty purchase, an entrant must be a Subway MyWay™ Rewards member and must opt in to receiving promotional emails from Sponsor (if entrant is not a Subway MyWay Rewards member, he/she can visit <https://www.subway.com/en-US/MyWayRewards> to become a member, at no cost). During the Game Period, an entrant may use his/her Subway MyWay™ Rewards account to purchase an item from a participating Subway location within the fifty (50) United States and the District of Columbia (“Qualifying Purchase”). Following a Qualifying Purchase, an entrant will, within approximately forty-eight (48) hours, receive an email (“Invitation Email”) from Sponsor at the email address associated with entrant’s Subway MyWay™ Rewards account. **Entrant must have opted to receive promotional emails from Sponsor, or entrant will not receive an Invitation Email.** Upon receiving an Invitation Email, during the Game Period, an entrant may click the unique link in the Invitation Email

to visit <https://subwaygoldentoken.com> (“Website”) and, if it is entrant’s first time visiting the Website, enter his/her first name, last name, and confirmation that entrant agrees to be bound by these Official Rules and is at least eighteen (18) years of age, after which entrant will receive one (1) game play (“Game Play”). Upon receiving a Game Play, an entrant will receive notification on the Website screen as to whether or not he/she is a potential winner (“Notification”). If an entrant receiving a winning Notification, he/she will be required to provide his/her street address (no PO Boxes), city, state, ZIP code, and phone number, after which entrant will receive an on-screen notification as to what prize he/she has potentially won. **Note: If entrant makes a Qualifying Purchase during the last forty-eight (48) hours of the Game Period, he/she may not receive an Invitation Email in time to receive a Game Play. Entrants may participate without making a purchase, as described in Section 3B, below.**

- B. Each entrant who receives a winning Notification will be deemed a potential prize winner, pending verification of the entrant’s eligibility and compliance with these Official Rules, as determined by Sponsor or its representative, in its sole discretion. An entrant is not a winner of any prize, even if the Website/Notification should so indicate, unless and until entrant’s eligibility and the potential winning Game Play have been verified as determined by Sponsor or its representative in its sole discretion. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. \*NBA All-Star Game Trip includes round-trip coach class air transportation from a major commercial airport near winner's residence to Charlotte, North Carolina for winner and one (1) guest; two (2) nights hotel standard accommodations (single room/double occupancy); two (2) tickets to the 2019 NBA All-Star Game scheduled to occur on February 17, 2019 (for winner and guest); select ground transportation; and a \$500 pre-paid card. Trip must be taken February 16 – 18, 2019.

- B. Total ARV:** The ARV of all Prizes in this Game is \$58,062.80.
- C. Odds of Winning:** The odds of winning a Prize depend on when the entrant completes a Game Play. Prizes will be made available at random times throughout the Game Period. The first person to complete a Game Play at or after the randomly predetermined winning time as determined by the Administrator will be a potential winner of a Prize. The number of Prizes available to be won will decrease during the Game Period as prizes are awarded and claimed.

Potential winners will be notified at the Website and via email after a winning Game Play. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN CONNECTICUT. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN BRIDGEPORT, CONNECTICUT. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR GAME ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. Entrants may be offered the optional opportunity to receive coupons, newsletters, informational materials, marketing communications, or other special promotions, or other offers from Sponsor, affiliates within the Subway® Group, and/or third-party service providers. Entrants will not be contacted for marketing purposes unless they have provided their consent.

By accepting a Prize, winner agrees to Sponsor's use of his/her name, city/province of residence, picture, biographical information, statements, voice and likeness in any advertising and publicity Sponsor and its respective successors, assigns and licensees may conduct relating to the Game in any media or format, whether now known or hereafter developed, including but not limited to the Internet, at any time or times in perpetuity, without further compensation or notice, and hereby releases Released Parties from any liability with respect thereto. If it is discovered that a person has registered or attempted to register more than once using multiple phone numbers, email addresses, residential addresses, multiple identities, IP addresses, use of proxy servers, or like methods, all of that person's Game Plays will be declared null and void and that person will not be awarded any prize that he/she might have been entitled to receive.
